In summary on November 8, 2021 a supervisor was requested to Berwyn City Hall regarding a subject video/audio recording customers and employees inside City Hall.

Upon arrival responding Sergeant entered City Hall and located Detective Monaco and Officer Ghiloni on the stair case leading to the 2nd floor speaking with a male subject later identified as Sean Paul Reyes.

At which time all three Monaco, Ghiloni and Sean Paul Reyes walked down to the first floor of City Hall. I then spoke with Detective Monaco who advised me that he was advised by City Administrator Ruth Siaba Green of said subject (Sean Paul Reyes) was electronically recording city employees and customers within City Hall building who were doing business, without having prior permission of doing so. It was also related that Sean Paul Reyes was asked to stop electronically recording, and that electronic recording is not allowed. After Mr. Reyes refused several requests Ruth Siaba Green requested a Supervisor from the Police Department.

I then spoke with Ruth Siaba Green who related she was contacted by employee's regarding a subject videotaping inside City Hall which frightened and threatened the employees. Ruth Siaba Green further related she will sign a criminal complaint if necessary.

I spoke with Shannon Reberski who related she observed a male subject near her desk and was going to ask him if he needed help. Once Shannon Reberski observed the male subject was videotaping the area she began to panic, because she has been recorded in City Hall in the past and a degrading video was posted.

I spoke with Tricia Powers who related she observed an unknown male subject who was walking around the second floor videotaping. She felt frightened because the office's located on the second floor, the Mayor's, City Administrator, and City Attorney offices are usually to be visited by appointment only.

I then spoke with Sean Paul Reyes and advised him he was not allowed to video record inside of City Hall without permission. Sean Paul Reyes continued to video record. I then asked Sean Paul Reyes what business was he at City Hall to conduct. Sean Paul Reyes related to request a Freedom of Information Act. I then directed him to the City's
